*When raw data is downloaded from the FCC, Cyrillic characters are translated into junk. However, the same string of junk characters in the address field appeared 325K times in our data analysis. A spot check of the names associated with the junk characters in the address field on the FCC’s ECFS system showed the Russian address highlighted above on each occasion checked.

Fake comments from France and the U.S. using pornhub.com domain extension. Note that U.S. addresses are incomplete, do not include states and don’t exist in the cities listed. Unless Pornhub was running a comment submission platform, it is exceedingly unlikely that 1 million comments were submitted from multiple countries using a pornhub.com domain extension.
